Application Instructions

Kent County Levy Court is currently accepting grant applications for the Fiscal Year 2026 budget. These grants support capital projects, community facilities, programs, purchases, and promotional events benefiting Kent County residents. To be considered, applicants must fill out the online application, and the application must be signed by an authorized representative. Requests should be reasonable and within grant fund constraints. Applicants may be asked to attend a Levy Court Business Meeting for consideration. Inquiries and submissions can be directed to the Kent County Levy Court Administration Office, Rm. 243, or via phone at 302-744-2300, or by email at admin@kentcountyde.gov.

The deadline for grant applications is March 15, 2025. If submitting by mail, the application must be postmarked by March 15, 2025.

Kent County Levy Court offers three (3) grant opportunities: Community Service Grants (County Policy § 22-3), Community Projects Contribution Fund Grants (County Policy § 30-1), and Community Event Promotional Grants. To help you decide which grant would best suit your needs, please find a brief description of each of the grant opportunities below:

- Community Service Grants: This grant fund allows the County to assist organizations which provide services to the community. Fire companies receiving County funds are exempt from the requirements of this Policy. In order for an organization to be considered for a community service grant, it must:
- 1. Be nonprofit (or under the umbrella of a parent organization which is nonprofit).
- 2. Have programs that are unduplicated and satisfy unmet needs of the community.
- 3. Practice nondiscrimination.
- 4. Have accounting (budget) procedures.
- 5. Use funds in accordance with the application.
- 6. Demonstrate community support.
- 7. Request funds only for a program which does not receive full funding from other sources of revenue.
- Community Projects Contribution Fund Grants: This grant fund shall be limited to non-County-owned capital projects of significant public benefit. Such projects may include, but not be limited to: educational buildings and facilities; recreational equipment and buildings; libraries; specialized transportation units; and similar community facilities and amenities.
- Community Event Promotional Grants: This grant fund is intended to provide financial assistance to municipalities to defray expenses associated with the promotion of small community events. Promotional expenses include: advertising costs; promotional brochures, pamphlets, cards, posters, or flyers; event signage; and similar promotional materials. In order to qualify for Community Promotional Grant Program funding, events must be open to the public and take place within the corporate municipal boundaries of the towns and cities in Kent County including the entirety of the corporate limits of Smyrna, Marydel, and/or Milford. A qualifying event, or events, shall be endorsed and/or hosted by a municipality in Kent County, Delaware. Qualifying events include but may not be limited to: Community Festivals; Parades; Fireworks Displays; Educational Programs; and similar events. The maximum grant award under this program is \$750.

Section 5: Statement of Assurances

Statements of Approval/Assurances:

- 1. All Community Grant monies received from Kent County Levy Court shall be used for the purpose of carrying out the primary mission of the receiving agency and this grant funding request.
- 2. Funds will be spent within Kent County, Delaware, whenever possible.
- 3. No person, on the basis of race, color, or national origin, should be excluded from participation in, be denied the benefit of, or be otherwise subjected to discrimination under the program or activity funded in whole or in part by these Grant funds.
- 4. All documents submitted by the applicant are defined as public documents and available for review under the Freedom of Information Act of the State of Delaware.
- 5. In the event that the awarded funding is used in violation of the requirements of this grant, the awarded funding shall be reimbursed to Kent County Levy Court within a timeframe designated by Kent County Levy Court by written notice.

For non-religious organizations, all expenditures must have adequate documentation and must be expended within one (1) year of receipt of award funds. The funding awarded to the organization must be used in substantial conformity with the anticipated expenditures set forth in the submitted application. All accounting records and supporting documentation shall be available for inspection by Kent County Levy Court within thirty (30) days after the organization's expenditure of the awarded funding, or within one year after the receipt of the awarded funds, whichever first occurs.

For religious organizations, all accounting records and supporting documentation shall be provided for inspection by Kent County Levy Court after the award has been made by the Levy Court but before the funding is released.

Disclaimer:

Community Projects Contribution Fund

The allocation of funding from the Community Projects Contribution Fund shall be limited to only those non-County-owned capital projects deemed by Levy Court to be of significant public benefit. Such projects may include, but not be limited to: educational buildings and facilities; recreational equipment and buildings; libraries; specialized transportation units; and similar community facilities and amenities.

If Levy Court determines that an appropriation should be made, the amount budgeted in any fiscal year budget shall not exceed a maximum of 50% of the surplus revenue from the most recently concluded and audited fiscal year or \$150,000, whichever is less.

Community Promotional Grants

Promotional expenses include:advertising costs; promotional brochures, pamphlets, cards, posters, or flyers; event signage; and similar promotional materials. All disbursements from this Grant Fund shall be approved by Levy Court. The maximum grant award shall be no more than \$750.00.

For an event to be eligible for funding from the Community Promotional Grant Program, it must meet certain requirements. The event should be open to the public and must take place within the corporate municipal boundaries of the towns and cities in Kent County, which includes Smyrna, Marydel, and/or Milford. Additionally, the event must be endorsed and/or hosted by a municipality in Kent County. Examples of eligible events include community festivals, parades, educational programs, fireworks displays, and other similar events.

Please note that certain events and activities are ineligible for funding under the Community Promotional Grant Program. These include invitation-only events, member-only events, age or gender-restricted events, service organization sponsored events, political rallies, social or political demonstrations, protest marches, and religious or theological events. Additionally, if an event has already received funding from the Annual Kent County Budget, it will not be eligible for additional funding through this program during the same fiscal year. To apply for funding, the promotional event application must be signed by a member of the host municipality.
